A bid for the power washing of building and front concrete, along with shrub trimming, was submitted to **Building and Grounds** chairperson ID Cleveland. The bid was discussed with a consensus made to delay decision making until the October meeting. Discussion was held about the bidding process, the raising of the concrete in the front, and the general maintenance of the building to make it more attractive. ID Cleveland will do further research on the needs and costs of building and grounds maintenance.

A letter was read by **Community Outreach** asking the Library Friends for assistance with library operations as well as a request for financial support to help defray the cost of the recently installed heating and AC system. Suggestions were made for the revision of the letter which will be sent to the Library Friends president.
