The March 1, 2022 Daugherty Public Library Board meeting was called to order at 7:00 pm by president Kim Kuni.

Librarian's Report was presented and discussed. Carol pointed out that in spite of an ARP grant being denied, the library will receive \$500 in free books for library.

Discussion was held regarding the continuation of Covid masking following suggestions made by the State of Illinois. A motion was made by Branson, second by Kolbe, to follow the same guidelines that are in place with the Dupo Public Schools. These guidelines state, "masks recommended but not required" by all personnel. Roll call vote was taken with Aguirre, LaCroix, Branson, Kolbe voting to follow the school guidelines, with Kuni placing a dissenting vote, Cleveland absent. Carol will place new signage stating the above on the front door of the library.

Discussion was held about revisions in the agenda format. These changes will be made by Carol. Carol also stated a five year plan needs to be developed by the library board.

## **Committe Reports:**

Finance – Linda Branson – Linda reviewed the need for a decision about the investment of endowment money into an interest bearing account to occur at the April Board meeting. This item will be placed on the April agenda for board vote. Also, a vote on the investment of the Daugherty Trust Fund monies will be place on the April Trust meeting agenda. Carol will include this when she makes the April agenda. Linda encouraged board members to being their ideas and opinions to the April Board meeting prior to vote.

Building and Grounds - ID Cleveland - no report due to ID's absence

Community Outreach - Marlene Kolbe - Marlene presented information researched regarding questions that arose about a proposed Friends of the Library activity that was canceled by the board at the February Library Board meeting. It seems that clarification of insurance issues, the relationship between Board and Friends, the role of the Friends, board oversight for protocols all need clarification and further discussion. Copies of the research addressing these issues were given to each board member to read and to take into consideration. Carol mentioned a possible meeting where the role of a Library Friends group is discussed by a consultant. Active discussion occurred about the issues presented and no action was taken. The roles of both entities might be formulated and included in a five year strategic plan.
