Minutes from the meeting were read by secretary pro temp, ID Cleveland. Motion made by Kolbe, second by LaCroix, to accept the minutes as read. Motion passed. Minutes will be filed for audit and notated as such in the minutes of the September trust meeting.

Bills for the past month were submitted for review and discussion. A motion made by Cleveland, second by LaCroix, to accept the bills as read. Motion passed. Bills will be filed for audit.

Expenditures were presented for discussion and review. A question was raised about a public relations expenditure. This question was tabled for further discussion upon the arrival of librarian Carol.

Committee Reports:

Building and Grounds – Cleveland – Randy Hamilton has been contacted about straightening the flag pole which was damaged in a storm. Mr. Hamilton suggested waiting until the end of October for the correction of the pole. There was no board opposition to Mr. Hamilton's suggestion.

Finance – Branson – no report due to absence

Community Outreach – Kolbe - Library Friends will be meeting this week, September 8th. Friends president Leslie Sopp has scheduled the annual Santa Breakfast for Saturday, December 3rd. Kolbe also stated the need for guidance from the Illinois Heartland Library System regarding the role of the Friends group as well as IHLS giving suggestions for a five year strategic plan. Kolbe also spoke of a T- Mobile Hometown Grant featured on the IHLS website. This grant is specifically designed to fund the development of community spaces and may provide an opportunity for the library to expand its services to the community. Kolbe will also ask the Friends if they would fund the replacement of one computer that cannot be repaired.

New Business:

Carol gave a short report regarding her attendance at the Village of Dupo Board meeting, being held the same evening as library board meeting. Her attendance centered around the discussion and implementation of a Story Walk in the Village park, a project promoted by the Dupo Public library board.

Pollowing her report, the board reviewed documents already presented, specifically bills, expenditures, and librarian's report.

Carol was asked to speak with Mitch Essert and/or research the dollar value of the library and it contents — this information may present a possible means to lower the insurance premium which had a substantial monetary increase in premiums for the oncoming year.

Carol clarified all questions board members had regarding bills and expenditures. After Carol's presentation, a motion was made by LaCroix, second by Cleveland, to ratify the expenditures presented for August, 2022. Motion passed. Expenditures will be filed for audit.

Carol presented information about three educational programs to be held in the library by library personnel. Hannah is doing a knitting class, Larissa is doing an American Sign Language class, and a painting class will be held. A small fee will be charged for the painting class, the others are free. All classes are being promoted via fliers and the library web site. There is a suggestion box asking the public for input regarding future classes.
